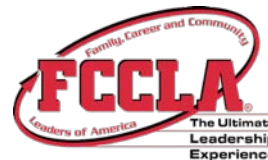

Congratulations on your decision to attend the National Leadership Conference in Atlanta, Georgia June 27 – July 3, 2018! All Colorado FCCLA chapters will be required to use National Travel Systems for their conference needs. National Travel Systems will take care of all flights, transportation, lodging, and payment for chapters. In order to meet established conference deadlines, the Colorado Deadline for National Leadership Conference commitment is **April 30, 2018 and payment received deadline of June 1, 2018.**

National Conference Registration

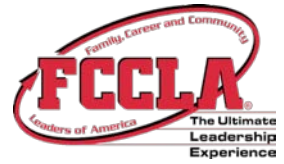

Additional Information:

Flight Check In: National Travel Systems will check in all chapters in for the flight and will have a representative at DIA/Atlanta for any questions.

Lodging Check In: National Travel Systems will check in all chapter rooms.

Registration Pick Up: Chapters must pick up their own registration.

Competitive Events: Please be advised that a chapter will have to have 1 volunteer per 3 STAR Event participants. All information regarding orientations (not mandatory but will incur a loss of points), competition times, and volunteer assignments will be available via the national FCCLA website in June 2018. Portfolio events will be required to use the FCCLA binder or will be subject to a loss of points at NLC.

Transportation: National Travel Systems will provide transportation to/from the airport in Atlanta as a part of the package.

State Meetings: All Colorado State Meetings at NLC are MANDATORY for all Colorado Delegates and Advisers to attend. The first State Meeting is Thursday, June 28 at 8:30 – 9:30 pm in the B212 room at the Georgia World Congress Center (GWCC). The second State Meeting is Saturday, June 30 at 4:45 – 5:30 pm in the B211 room at the GWCC.

Colorado State Tour: As a part of the package, package 1 attendees will go on a tour of the [Civil Rights Museum](#) on June 28 from about 10:45 am to 3:30 pm. This tour includes transportation to/from the venue, admission, and lunch at the Hard Rock Cafe. Those chapters in package 2 will not participate in this tour.

Meals: Delegates will be financially responsible for 15 to 18 meals at NLC. Please note that meals are sometimes provided with tours and special events.

State Trading Pins: Trading pins with other state delegations encourages networking and collaboration while at NLC. You may order trading pins through the State Office using this [Trading Pins Order Link](#). All orders must be placed by May 10. You can purchase 10 pins for \$10. Payment for pins is due by June 1 to Colorado FCCLA.

Additional Tours: All tours must be registered for online so you will do this **individually** as a chapter. See the FCCLA website for complete tour information and availability.

Code of Conduct Form: Each student attending NLC must have the NLC Attendance Permission Slip and Colorado Code of Conduct signed. Advisers are required to have them with them at all times.

Multiple Release: It is required that in addition to the original copy of the [medical release](#) carried by the adviser of each chapter and each delegate should have a copy of their medical release on their person at all times. A reduced size is acceptable. Emergency medical assistance is available by dialing the hotel operator.

FCCLA Forms: All conference delegates are required to complete and turn in these [FCCLA NLC Forms](#) upon picking up registration.
